Driving forward electric mobility with a new range of charging points

At the end of 2024, our ViTO service stations launched an offer for charging electric vehicles.

The V-CiTY offer includes fast-charging points strategically located around the territories and a mobile application to locate the stations, manage charging sessions and optimise expenses.

By meeting the growing expectations of electric vehicle drivers, Rubis is offering a high-performance, reliable service in synergy with the additional services offered at our stations (restaurants, shops, relaxation areas, etc.), thereby strengthening our value proposition.

FrancePhotovoltaics

Developing French berry production through agrivoltaics

Rubis Photosol has teamed up with Fruits Rouges & Co and Insolight to install semi-transparent solar panels as an alternative to plastic tunnels. This innovative solution will protect fruits from bad weather, reduce evapotranspiration and optimise water use, while automatically adjusting shading using climate sensors. Fruits grown this way will qualify for the label 'positive energy fruit'.

A 20-year renewable power purchase agreement has also been signed with Fruits Rouges & Co. The photovoltaic electricity will be used by the company for its cooling and fruit preservation needs, creating a virtuous and sustainable synergy.
