International strategy rationale



EU – A FORMIDABLE ACCELERATOR FOR REN



- Strong political push for REN in EU REPowerEU plan to reduce dependency on Russian fossil fuels, accelerate the transition to renewable energy, and improve energy security reducing
- EU requirements for decarbonizing energy mix in Eastern Europe
- Implementation of grid reinforcement plan in 10 lower-income EU member states supported by EU (EU Modernization Fund 2021-2030)
- EU post covid' resilience plan has REN conditions to be eligible

ENERGY MARKET – NEW PARADIGM



- Geopolitical context with Russia which has stopped gas delivery
- Low market penetration for nuclear powerplant (complex technology, costly and very long implementation phase)
- Implementation a/o amendment of national regulations to ease penetration of storage mitigating PV cannibalization risks and enhancing grid stability
- Increasing demand for PPA leads by reducing carbon emission from large consumers and price exposure

PHOTOSOL STRATEGIC PILLARS



- Reducing risk exposure to regulatory changes through a multi-market exposure
- Reach a critical size which enhance our competitiveness
- Well balanced offtake scheme with a mix of contracted revenue (optimizing leverage) and merchant (optimizing payback)

- A permanent base with a dedicated Photosol team
- Countries where at least one DSA is in place
- Entry to be approved
